INTRODUCTION

The original North Dakota Telephone Association (NDTA) was organized in 1906 and functioned until it was disbanded in March 1973. In 1982, the Association was reactivated to address the operational needs of the industry. An organizational meeting was held on November 17, 1982, which resulted in the incorporation of the present Association on September 28, 1983.

The purpose of NDTA is to address common telecommunication industry needs by:

- 1) Providing information and assistance in matters of industry-wide importance.
- 2) Providing workshops, seminars, and conferences as a means of establishing a forum for the expression of ideas, discussion of problems of the member companies and educational opportunities.
- 3) Providing a clearinghouse for the compilation, publication and distribution of information affecting or of interest to its member companies.

Active membership in NDTA is available to any incumbent local exchange carrier operating a local telephone exchange or exchanges in North Dakota under a Certificate of Convenience and Necessity issued by the North Dakota Public Service Commission.

Affiliate memberships are available to incumbent local exchange companies serving North Dakota subscribers from a telephone exchange in a state adjacent to the state of North Dakota.

Associate memberships are open to suppliers (consultants, engineers, accountants, directory companies, equipment manufacturers and reps) who provide products and services to the telephone industry.

Sustaining memberships in NDTA are open to corporations who desire to aid in the purpose of the Association, such as:

- 1) Inter-exchange carriers who provide inter-exchange long distance service to ND customers.
- 2) Resellers of long distance telephone service to ND customers.
- 3) Wireless carriers and network providers who provide telecommunications service to ND customers.
- 4) Partnerships or corporations having ownership in a ND telephone company.
- 5) All carriers that provide local exchange telephone service on a competitive basis in North Dakota and are owned wholly, or in part, by an Active or Affiliate member of this Association.

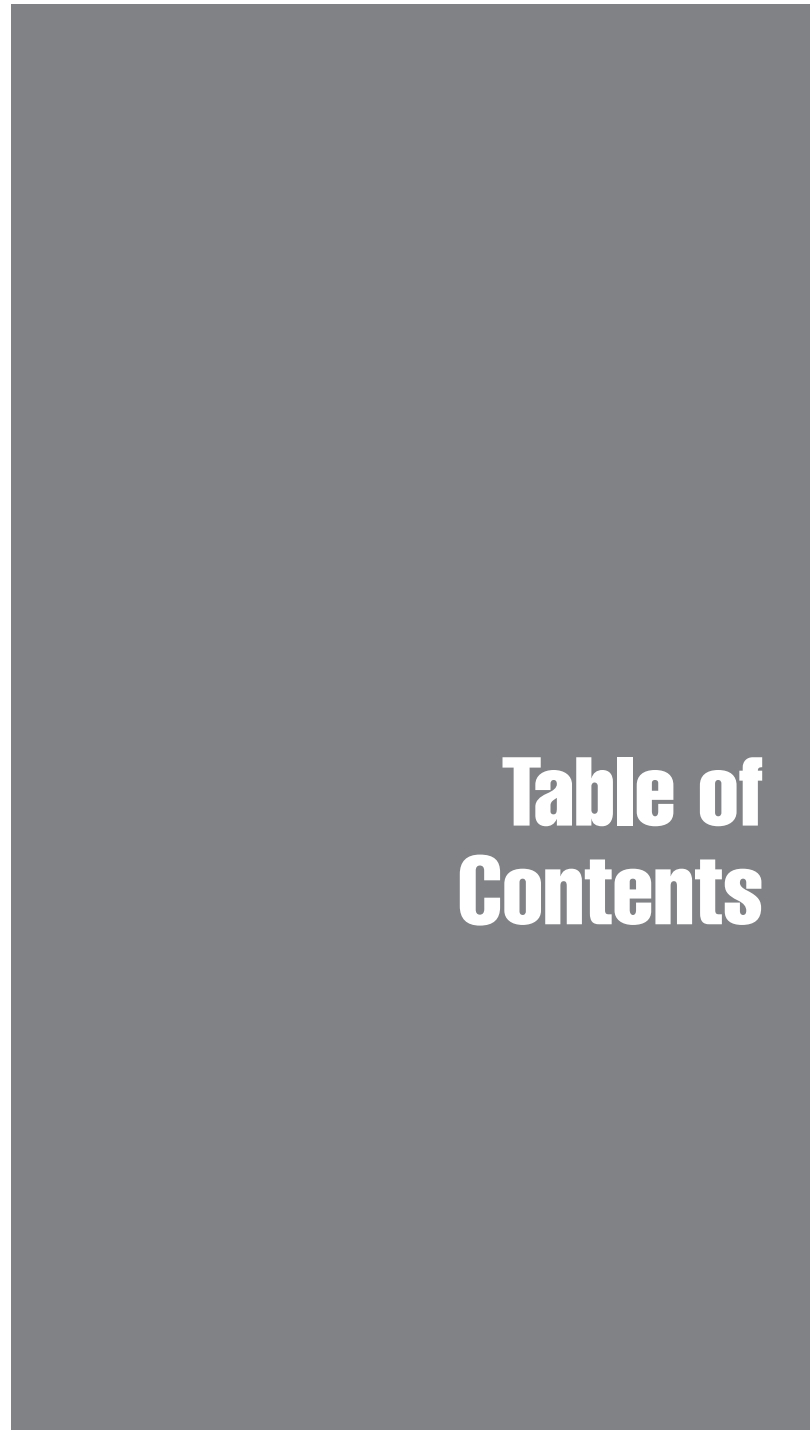
